Tanveer Banu Starts her Multi-Service Business

Tanveer Banu lives in the economically depressed area of Tandalja but that has not kept her goals depressed. Far from it. By way of background, her husband is a clerk in government and she has two daughters and one son who all are working hard to get professional degrees.

Tanveer attended I Create Sneh Deep's full length Aspiring Entrepreneurs' Workshop in Vadodara in December 2012. Mr. Joseph Pius who led the workshop and has been her mentor was impressed by Tanveer's devotion to the workshop and lessons she internalized. She started looking for opportunity for a small business.

She thought of catering business as an option and finally got an opportunity to use her training skills and convert it into her own business. She started by getting a subcontract for conducting skill training classes for Umeed project of Gujarat Govt.

She was then emboldened to enlarge her business and found resources to invest Rs one Lac to buy computers, accessories, other equipment and

create marketing materials such as brochures and pamphlets.

Her business has started well. She offers classes in basic computers, Tally

accounting software, DTP, Photoshop, as also conducts beauty parlor classes and sewing classes. One stop shop!

They have taken a loan from relatives and raised own funds. The good thing is that she has complete support of her husband.

Tanveer is now a self employed entrepreneur and has created three more full time jobs and has a monthly payroll of Rs 18,000.

One less on to aspiring entrepreneurs. Tanveer does not have to pay rent for their premises and for electricity since these are provided by Vadodara Municipal Corporation.

Knowing that their client base comes from poorer section of the society, she charges only Rs.500/- per month for a 3-month course.

We would like to have many more case studies like this which highlights the work that has been done by dedicated people like you and compile the same for use.
